SKOR Food Group Inc. Corporate Update

TORONTO, Dec. 10 /CNW/ - The SKOR Food Group Inc. (TSX.V: SKF) ("SKOR"), a vertically integrated Food service distributor, wholesaler and manufacturer is pleased to provide a corporate update on activities since October 1/08.

SKOR operates three divisions, Skor Food Service, Skor Cash & Carry and Skor Culinary Concepts. The Company is profitable with annual revenue of approximately \$160 million.

The Wholesale Cash and Carry division serves the independent convenience and small grocery trade. As per previous disclosure and effective today, management has closed three (3) non performing locations throughout Southern Ontario. These are located in the cities of Mississauga, Scarborough and Tillsonburg. The inventory and assets from these units will be redeployed into the other nine locations. This decision will help to improve both profitability and cash flow for the company overall.

On December 3, 2008 SKOR also sold the assets of Galaxie Diner acquired in 2006 back to the original vendor for the same consideration as originally paid. As part of that consideration SKOR will receive and return to treasury 145,000 shares of SKOR issued at time of purchase.

"The closure of the above units and the sale of Galaxie will reduce revenue but at the same time it will improve profitability," said Vince Capobianco, President and CEO SKOR Food Group. "Our focus is on operational excellence and profitable revenue growth, while building our brand in the marketplace."

SKOR, through its operating divisions Skor Food Service, Skor Culinary Concepts and Skor Cash and Carry, is a vertically integrated, full service, wholesale food supplier to the food service and retail industries. SKOR serves a wide range of multi location food service establishments, Quick Service Restaurant chains, day care facilities, government institutions, independent food service operators, independent grocery stores as well as vending operators and convenience stores in Ontario.
