Skor Food Group Reports Strong Growth in Revenue and Earnings

Q2 EARNINGS INCREASE 252%

TORONTO, April 26 /CNW/ - The Skor Food Group Inc. (TSX.V: SKF) ("Skor"), a rapidly growing, broad line food service distribution Company announced strong growth in revenue and earnings for the three and six month periods ended February 28, 2005.

Second quarter, year over year, revenue increased 101% to \$17,832,822 from a combination of strategic acquisitions and organic growth. Net Q2 earnings increased on a year over year basis by 252% to \$325,633, a function of increased sales and increased gross profit margins. The six month results are not indicative of full year results, as revenue is generally seasonally stronger in the 3rd and 4th quarter of the fiscal year.

Skor enters the second half of fiscal 2005 in a strong financial position to fund the near term growth with working capital of \$5.5 million and unused lines of credit of \$3.5 million. The Company remains committed to growing and enhancing profitability by streamlining and consolidating its operations. During the quarter the Company reviewed a number of acquisition opportunities and is actively continuing negotiations with two candidates both of which will help the Company to begin its vertical integration objectives.
